RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

I am aware that travel to and participation in the Games to be held at Edmonton, Alberta on June 30 - July 3, 2011 organized by His Highness Prince Aga Khan Shia Ismaili Councils for Canada and Edmonton (the "Organizer") has inherent risks and **I freely accept and fully assume all such risks**, and the possibility of personal injury and damage or loss to personal property resulting from travel to and participation in this activity. I agree as follows:

1. **TO WAIVE ALL CLAIMS** that I have or may have in the future against the Organizer, His Highness Prince Aga Khan Shia Imami Ismaili Council for Canada, and local Councils (including without limitation the Council for Edmonton) (collectively, "the Council"), the Organizer, sponsors of the Games and other persons acting on behalf of the Council or the Organizer or assisting with the Games in any manner whatsoever (all of whom are hereinafter collectively referred to as "the Releasee"), as a result of my travel to and participation in the Games due to any cause including negligence, breach of contract, or any other duty of care.
2. **TO HOLD HARMLESS AND INDEMNIFY THE ORGANIZER AND RELEASEES** from any and all liability for any damage to the property of, or personal injury to any third party, resulting from my travel to and participation in the Games; and
3. That this agreement shall be effective and binding upon myself, the participant named above, my heirs, next of kin, executors, administrators, assignees, and representatives in the event of my death or incapacity.

In entering into this agreement, I am not relying upon any oral or written representations or statements made by the Providers and Releasees other than what is set forth in this Agreement. Additionally, I understand that I have the opportunity to seek independent legal advice prior to entering into this agreement.

I (THE PARTICIPANT OR PARENT/GUARDIAN) HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE, WHICH, I, OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNEES, MAY HAVE AGAINST THE ORGANIZER AND RELEASEES.

I (THE PARTICIPANT OR PARENT/GUARDIAN) CONSENT TO TRAVELLING OR ALLOWING THE PARTICIPANT TO TRAVEL TO THE GAMES AND ACCEPT ALL RESPONSIBILITY FOR AND WAIVE ALL CLAIMS RELATED TO THE TRAVEL FOR THE GAMES.

I (THE PARTICIPANT OR PARENT/GUARDIAN) HAVE READ AND UNDERSTOOD AND ACCEPT THE CANADIAN ISMAILI GAMES CONDUCT POLICY AND THE TERMS CONTAINED THEREIN. I AGREE TO ABIDE BY THE CONDUCT POLICY AND TERMS AND CONDITIONS THEREIN.

I (THE PARTICIPANT OR PARENT/GUARDIAN) CONSENT TO THE USE OF MY/THE PARTICIPANT'S NAME, IMAGE, AND ANY VIDEO FOOTAGE OF ME AT THE GAMES FOR THE PURPOSE OF NON-COMMERCIAL PROMOTION AND DEVELOPMENT OF SPORT, AND THE GAMES. NO COMPENSATION SHALL BE PROVIDED TO ME.
